Dual-Fuel Heat Pump Rebate Qualification Standards

Eligibility:

- Only Berkeley Electric Cooperative, Inc. members are eligible.
- Residential existing all gas unit replacement and newly constructed homes are eligible (and lower rebate level for heat pump to dual fuel).
- One rebate per home is available for installation of a Dual-Fuel Heat Pump.

Dual-Fuel Heat Pump Equipment:

- Only Dual-Fuel Heat Pumps (DFHP) will qualify.
- Each DFHP system must include a new heat pump outdoor unit matched with a new indoor coil and new air handler/gas furnace.
- The system capacity must be determined by an ACCA Manual J load calculation.
- Each system must be controlled by an outdoor sensor or thermostat that shall prevent operation of heat pump compressor below the temperature of **32 degrees F**.
- Equipment must be capable of complete automatic switching from heat pump mode to supplemental gas heating.
- The use of supplemental electric resistance heaters is not permitted.
- All equipment must be properly matched and AHRI rated.
- The HVAC contractor must hold a valid S.C. Mechanical Contractor license.
- Installations must be in compliance with all state and local codes.

Dual Fuel Heat Pump Rebate Details:

- \$1,000 rebate for Gas to Dual Fuel Heat pump, \$500 for Heat Pump to DFHP (one per home).
- Rebate will be mailed to homeowner within 4 weeks of completion date.
- A copy of the sales invoice must be included with application to verify unit was purchased and installed.
- The application must be completed in full including all model and certificate numbers.
- A copy or info from AHRI certificate or manufacture's catalog page should be included with application.
- The equipment must have been installed within one year of the date of application.
- The homeowner must allow for an inspection by a Berkeley Electric Cooperative representative to ensure compliance with the program standards.
