Committee Reports

ECSC Board Report-Willis Sanders

Mr. Sanders covered the highlights that were discussed at the ECSC board meeting on June 5th.

Central Meeting Report-Mr. DeWitt

CEEUS Meeting Report-Mr. Gourdine

Mr. Gourdine stated the CEEUS board meeting was held on June 4th at the ECSC Summer Conference. Mr. Gourdine reviewed the meeting highlights from the CEEUS board meeting and the Line Equipment board meeting.
